



Board Member Application

The Peoria Chamber of Commerce is always interested in qualified leaders to serve on the Board of Directors in either a 1 year appointed or 3-year selected position. The intention of the Peoria Board is to attract a well-rounded group of dedicated professionals, representing the City of Peoria and the West Valley. Board members must possess the time commitment and company resources to guide and grow the Chamber through Board support, long-range planning (5+ years), community relations and fundraising. Candidates must be active Chamber members for at least one (1) year at the time of application.

Board Composition

The Board is comprised of 11 selected Board members (serving in 3-year terms) and up to six appointed Board members (serving in 1-year terms). All Board members have voting rights. The Board reserves the right to appoint only qualified candidates.

Required Skills

The position calls for leadership qualities of the highest standards. The Board member must be aware of the importance of public opinion and promote the value of Chamber membership and the benefits derived. The ability to delegate authority while retaining responsibility is of high importance. Board members understand they individually and collectively represent all members of the Chamber and not just the business of which he or she is affiliated. As representatives of the public, the board member will be the primary force pressing Peoria Chamber of Commerce, Inc. to the realization of its opportunities for services and the fulfillment of its obligations to all its constituencies. Board members are required to have experience in planning (short and long term), organizational development, operations (small, medium or large business) and community experience.

Desired Skills

Selected Board members are chosen based on career experience, company position and overall skill sets. Applicants from all industries will be considered.

Board members bring expertise, experience and resources to the Chamber's Board, including:

- Ability to leverage people and/or financial resources from member's own company
- Contacts suitable to expand the Chamber's reach through executive management in other companies
- Commitment to help drive membership thru referrals and endorsements.
